## NORTHEAST AREA & GOOSENECK CREEK SOUTH NEIGHBORHOOD SEWER REHABILITATION PROJECT

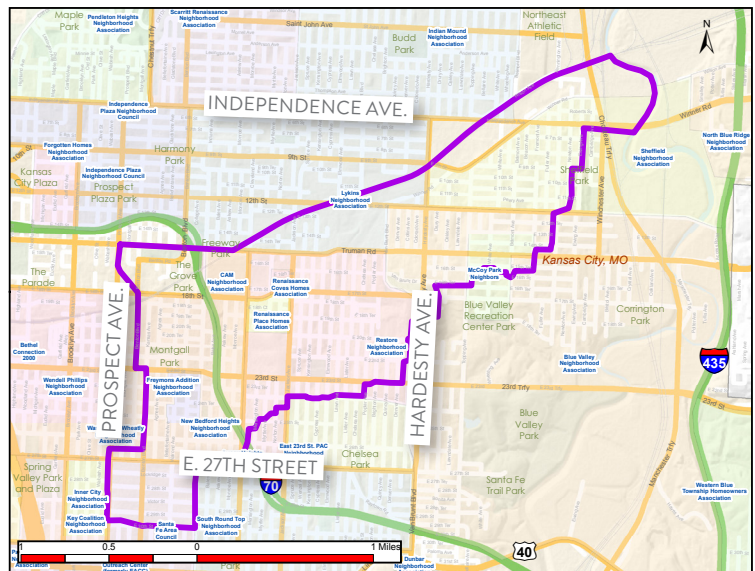
CONSTRUCTION SCHEDULED FOR: DECEMBER 2018 – MAY 2020

The City of Kansas City, Missouri is working to construct important improvements to the wastewater system in your neighborhood. This project will rehabilitate sewer mains, service laterals and manholes in your area to like-new conditions, with a life expectancy of up to 80 years of service. When complete, the project will restore capacity to the wastewater collection system, and lessen the frequency of sewer overflows and basement backups.

### PROJECT AREA

THIS PROJECT IS LOCATED WITHIN THE NORTHEAST INDUSTRIAL DISTRICT AND GOOSENECK CREEK BASIN. THE BOUNDARIES ARE:

- NORTH: KANSAS CITY TERMINAL RAILWAY
- SOUTH: E. 30TH STREET
- EAST: BLUE RIVER
- WEST: PROSPECT AVENUE

# NEIGHBORHOOD SEWER REHABILITATION: NORTHEAST AREA & GOOSENECK CREEK SOUTH

## WHAT'S BEING DONE?

The scope of work for this project entails the rehabilitation and/or replacement of:

- Approximately 61,000 linear feet of sewer mains
- Approximately 715 service lateral connections
- Approximately 80 manholes

## WHAT'S THE TIMELINE?

Construction is anticipated to begin in December 2018 and end in May 2020.

## WHAT CAN YOU EXPECT?

We appreciate your support and patience as we work to complete this important community project. Customers will be notified in advance of pending disruptions, which may include:

- Large equipment creating noise and dusty conditions
- Temporary street closures
- Temporary sewer service disruptions

## WHO'S DOING THE WORK?

The City of Kansas City will be assisted by Taliaferro & Browne, Inc., Blue Nile Contractors, Inc., and Larkin Lamp Rynearson.

## WHAT'S THE CONTRACT AMOUNT?

The budget for construction is \$8,900,000.

## WHAT'S THE "CONSENT DECREE"?

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency to reduce the volume and frequency of overflows from the City's sewer system. Kansas City's Smart Sewer program is a 25-year plan to address this challenge. The Northeast Area and Gooseneck Creek South Neighborhood Sewer Rehabilitation Project is one piece of the Smart Sewer program, and is required by the Consent Decree to be completed by December 31, 2020.
