Due to age and deterioration of current infrastructure, KC Water plans to replace approximately 5,930 feet of break-prone 2-inch, 4-inch, 6-inch, and 8-inch cast-iron water pipes with more durable ductile-iron water mains.

WHO

 KC Water in association with Blue Nile Contractors

WHAT

- Important infrastructure work will be performed in your neighborhood.
- Water mains will be replaced with larger diameter and more durable pipes.

WHEN

 Weather permitting, work will begin in mid-October 2019 and conclude in April 2020.

WHY

 KC Water is undertaking this project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection.

IMPROVEMENTS

- Fewer anticipated water main breaks
- Increased reliability
- Fewer service disruptions
- Enhanced neighborhood fire protection

WHERE

- Along 110th Street from Holmes Road to Virginia Avenue
- Along Walnut Street from Red Bridge to E. 113th Street
- Along 114th Street from Glen Arbor Terrace to Wornall Terrace
- Along 116th Terrace from Troost Avenue to 117th Terrace

WHAT TO EXPECT

- Water meters located inside existing structures will be replaced and relocated outside of the structure in a small, secure, covered vault in the ground.
- Large equipment will be used, creating noise and dusty conditions, which will be controlled.
- Affected curbs, driveways, and other pavement will be replaced.
- Disturbed lawns will be restored after work is completed and as the season permits.
- Ordinary travel routes may be temporarily restricted.
