



# WATER MAIN REPLACEMENT

### In the Area of W. 75th Street and Wornall Road

Due to age and deterioration of current infrastructure, KC Water will be replacing approximately 5.8 miles of break-prone 4-inch, 6-inch, 8-inch and 12-inch cast-iron water mains in an area bordered by West 65th Street on the north, West 81st Street on the south, Flora Avenue on the east and State Line Road on the west, including a 20-inch water transmission main along 75th Street from State Line Road to Holmes Road.

# WATER MAIN REPLACEMENT

In the Area of W. 75th Street and Wornall Road

### **WHO**

 KC Water in partnership with Rodriguez Mechanical Contractors Inc.

### **WHAT**

- Important infrastructure work will be performed in your neighborhood.
- The intersection of Wornall Road and 75th streets is directly affected and will be completed in approximately 45 days from the time construction commences.
- Water mains will be replaced with larger diameter and more durable pipes.
- Indoor water meters will be replaced and relocated outside homes.

### **WHEN**

 Weather permitting, work will begin August 2019, and conclude in approximately 12 months.

### WHY

 KC Water is undertaking this project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection.

### **IMPROVEMENTS**

- Fewer anticipated water main breaks
- Increased reliability
- Fewer service disruptions
- Enhanced neighborhood fire protection

- Mercier Street from Ward Parkway to approximately 245 feet north to an existing water main
- Meadow Lake Parkway from State Line Road to Terrace Street
- East 75th Street from Holmes Road to Troost Avenue
- Harrison Street from Charlotte Street to 75th Street
- West 76th Street from Mercier Street to the fire hydrant on the east side of Ward Parkway
- Ward Parkway from Meadow Lake Parkway to West 76th Street
- Ward Parkway from West 81st Street South to an existing water main

### WHAT TO EXPECT

- Streets and intersections including 75th Street and Wornall Road – will be temporarily restricted. The intent is to keep at least one lane in every direction open at all times.
- Water service will be interrupted for short periods. You will be notified beforehand with door hangers or by other means.
- Large equipment will create noise. Dust will be controlled.
- Water meters inside homes will be replaced and relocated. If affected, we will require access to your meter.
- Affected curbs, driveways, sidewalks and lawns will be restored.
